


## REACH declaration

In June 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) was first released. This Regulation establishes specific duties and obligations for companies in the European Union (EU) that manufacture or import substances on their own or in products.

- Under the structure of the REACH Regulation, Thermaflex is a manufacturer and supplier of products to our customers through Thermaflex entities located within or outside the EU. We do not manufacture, or supply substances and our products do not involve the “intentional release of substances”. Accordingly, we foresee no registration or pre-registration requirement for the products, systems, or solutions we supply to our customer.
- Thermaflex believes that even though REACH is an EU regulation, the Thermaflex products, systems or solutions are affected in all geographical regions. Therefore, Thermaflex wants to comply and implement this REACH declaration on a worldwide basis.
- Thermaflex provides (on request) Safety Data Sheets (SDS) for all products. The information in the SDS is provided by Thermaflex on a “best effort” basis using the information provided by our suppliers, published data and the documentation from the European Chemical Agency (ECHA).
- Thermaflex is constantly monitoring the Substances of Very High Concern (SVHC), as defined by REACH, in our products, systems and solutions. This will be an on-going process since the complete list of SVHC is updated twice a year.
- Thermaflex products, systems and solutions (products) do not contain SVHC and the Candidate list above the threshold value declared as per ECHA.
